

Terms of Use

A. General

1. For the purpose of these Terms of Use, “Content” refers to all content, information and materials on the socialprotection.org website.
2. The Terms of Use apply to all socialprotection.org’s Users and Members.
3. socialprotection.org is hosted by the International Policy Centre for Inclusive Growth (IPC-IG) of the United Nations Development Programme (UNDP), by the socialprotection.org Team.
4. “Members” refers to individuals who are registered to socialprotection.org.
5. “Users” refers to individuals who access the Site but are not registered to the Site.
6. “Site” refers to socialprotection.org.
7. These Terms of Use constitute a legally binding agreement under the authority of the UNDP.
8. All rights are reserved by these Terms of Use.

B. Visitor and User Conduct
