- UNDRR | 2023 | <u>Analysis of barriers in financing and operationalizing linkages between anticipatory action and social protection systems</u> reviews the feasibility, behavioural and political-economy factors that affect the demand and financing of anticipatory action programmes integrated into government social protection systems.
- Centre for Humanitarian Leadership | September 2023 | Envisioning an alternative ecosystem for global development and humanitarianism challenges the terms 'decolonisation' and 'localisation' and their usage in the development and humanitarian discourse by taking a more radical view.
- IASC | June 2023 | Grand Bargain beyond 2023 outlines the proposed scope, timeline and governance for the future of the Grand Bargain.
